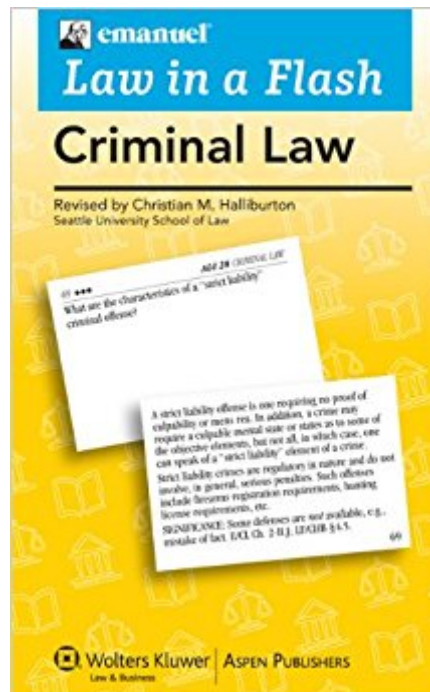

I'm a big fan of the Law in a Flash series. These cards make for a great supplemental study aid. The best feature, in my opinion, is the "scenario" questions. These are like mini-fact patterns designed to get you thinking about one particular issue. I've found these to help get my mind around particular topics in a format conducive to an essay style exam (which all of my instructors use). I do wish that the cards had some more "concept w/definition" cards (where one side gives a word, concept, or issue, and the answer side has a rote definition), but it's not a major issue. I also do think that there was a bit too much repetition at times, and the product could have been pared down a bit. But maybe that repetition helps some people, despite annoying people like me.

I like that the questions weren't overly easy. There was some challenge. The explanation on the back is great reinforcement. The only problem I had was the questions which were very similar to each other. I understand, it's the same topic- but I was hoping for a variation in the fact pattern to

really test my skills. But overall- I like it.
