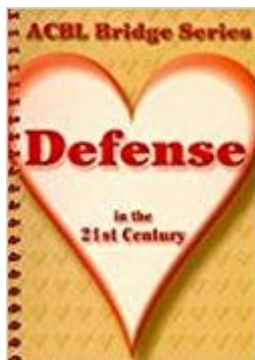

Great book for most bridge players. Grant teaches how to think and respond to a variety of situations as well as cues to tell partner about your hand. Deals, bidding and defensive strategies are clearly explained, by reviewing these plays, it keeps me progressing and learning to be a more effective player.

This the third in a series of bridge books for beginning and intermediate players but could serve as a review for anyone who hasn't played in a while (although defense really hasn't changed anywhere near as much as bidding). I would strongly recommend one starts with Bidding, then Play of the Cards before going on to this volume. The spiral binding and format make it very convenient.

Audrey Grant is always excellent. No exception here. Defense in the 21st Century is excellent. Recommended to me by an excellent teacher.

This book helped me so much in playing bridge and defending. I had concentrated more on winning the bid and making the contract and usually lost interest in defending.
